**AN ORDINANCE CONCERNING**

**Code of the Town of Elkton  
Title 10  
Chapter 10.12  
Parking Meter Zones**

**FOR THE PURPOSE** of amending the Code of the Town of Elkton, Title 10, Chapter 10.12, **Section 10.12.060 – Parking meter zones established – On-highway parking zones.**, to limit enforcement hours in metered zones.

**WHEREAS**, the Constitution of the State of Maryland, Article XI-E; Article 23A, Annotated Code of Maryland; and the Charter and Code of the Town of Elkton, provide the authority under which the Board of Commissioners may adopt, repeal, and/or amend the ordinances of the Town of Elkton; and

**WHEREAS**, the Mayor and Commissioners have determined that metered zones on the streets specified in Section 10-12.060 shall be modified to limit parking enforcement between 8:00 a.m. – 4:00 p.m., except as set forth in the section.

**NOW, THEREFORE, the Mayor and Commissioners of the Town of Elkton hereby ordain that:**

- Section 1: The Code of the Town of Elkton, Title 10, Chapter 10.12, § 10.12.060, shall be repealed; and
- Section 2: The Code of the Town of Elkton, Title 10, Chapter 10.12, §§ 10.12.060, shall be re-enacted and read as follows:

§§10.12.010 – 10.12.040      No change in text.

§10.12.050                      Suspension of provisions.

- A.      Temporary Suspension of Provisions. The provisions of this chapter may be temporarily suspended by a resolution of the Mayor and Commissioners and they may prescribe temporarily such other rules and regulations as traffic conditions may require.
- B.      Suspension of Provisions on Designated Holidays. The use of parking meters throughout the town shall be suspended on holidays as designated and set forth by a resolution of the Mayor and Commissioners.

§10.12.060                      Parking meter zones established – On-highway parking zones.

Parking meter zones are established upon the streets, parts of streets, or parking lots described below, with maximum parking time periods as indicated on all days, except Sundays and holidays, during the hours of 8:00 a.m. to 4:00 p.m.:

<u>Name of Highway/Lot</u>	<u>Side</u>	<u>Time Limit</u>	<u>Location</u>
Bow Street	Both	2 hours	From Railroad Avenue to Cathedral Street
Bow Street	East	2 hours	From Cathedral Street to Main Street
Cathedral Street	South	2 hours	From Bow Street to Singerly Avenue
High Street	Both	2 hours	From Grooms Lane to Singerly Avenue
Main Street	Both	2 hours	From South Street to Grooms Lane
Singerly Avenue	West	2 hours	From West High Street to Cathedral Street
South Street	West	2 hours	From Howard Street to Main Street
South Street	East	2 hours	From Main Street 135 feet in south direction
South Street	Both	2 hours	Main Street to East High Street
