CASE # 1445 – REQUEST OF RUFF NEON SIGNS, 9287 MERCANTILE DRIVE, MENTOR, OHIO FOR A VARIANCE TO REQUEST FIVE (5) ADDITIONAL WALL SIGNS AND FOR RELAXATION OF THE WALL SIGN SIZE REQUIREMENT OF 40 SQUARE FEET FOR THE FOLLOWING SIGNS; SIGN #1 BY 32 SQUARE FEET; SIGN #4 BY 32 SQUARE FEET AND SIGN #5 BY 11.2 SQUARE FEET. THIS ACTION CONCERNS PROPERTY LOCATED AT 221 BELLE HILL ROAD, ELKTON, MARYLAND, TAX MAP 303, PARCEL 2120, ZONED C-3

Ms. Jessica Ruff of Ruff Neon Signs was in attendance to address this request. She reviewed each sign which the Board would need to come to a decision regarding.
