CASE # 1517 – REQUEST OF RACKSON CAPITAL CIRCLE, LLC REPRESENTING BURGER KING FOR A VARIANCE FOR ONE (1) ADDITIONAL WALL SIGN. THIS ACTION CONCERNS PROPERTY LOCATED AT 100 WEST PULASKI HIGHWAY, ELKTON, MARYLAND, TAX MAP 315, PARCEL 2210, ZONED C-2 (HIGHWAY COMMERCIAL)

Mr. Christopher Johnson of Rackson Capital Circle, LLC was sworn in to address this variance request for Burger King. He stated the restaurant was recently remodeled and they are requesting to replace the older signage on the building with new signs as well as a request for one additional wall sign.

Mr. Olewine asked whether this sign package is consistent with what the overall restaurants are doing. Mr. Johnson confirmed the restaurants which are being remodeled are placing new signage. There was a question regarding the number of signs being placed. Ms. Humphreys noted that the restaurant is on a corner lot and therefore they are allowed two signs. They are requesting one additional sign in order to place three signs. Mr. Olewine asked if the new sign would be facing Route 213 and would be lighted. Mr. Johnson answered affirmatively.

Mr. Olewine entertained any comments from the Board. Ms. Schwartz asked if the new sign was the same size as the other signs. Mr. Johnson confirmed they are the same size. Ms. Schwartz thanked Mr. Johnson for making the upgrade to the store and signage. Mr. Johnson noted he had purchased the store within the last year.
