# The Mayor and Commissioners of the Town of Elkton

The Mayor and Commissioners of the Town of Elkton (the "Board") held a regularly scheduled meeting on this date at 12:00 p.m. The following persons were present: Mayor Robert J. Town Administrator Lewis H. George, Jr. was excused from the meeting.

# Notice of Closed Meeting

On Wednesday, March 16, 2022, during a regularly scheduled meeting of the Mayor & Commissioners of the Town of Elkton (the "Board"), a Closed Meeting was requested and approved by all present pursuant to State Government Statutory Authority to Close Session, General Provisions Article, §3-305(b) (7) To consult with counsel to obtain legal advice on a legal matter. # **Town Administrator's Report**

# **Bid Opening Project 2021-001 Well House #4**

Mayor Alt, noting Mr. George's absence from the meeting, asked Ms. Henson to open and read the bids into the record of the minutes.

Assistant Town Administrator L. Michelle Henson stated the Town received (4) bids for Project 2021-001 Well House #4. She stated the project will entail construction of a well house and related equipment in order to connect the Town's water system and proposed related Water Storage Tank.

Ms. Henson read the bids into the record of the minutes. The bid results are as follows:

**<u>ACTION</u>:** The request from the Elkton Alliance for Waiver of Alcohol Prohibition and Road Closure for the above referenced events was approved on a motion made by Commissioner Givens. The motion was seconded by Commissioner Piner and approved by all present.

# **Mayor Alt's Report**

Mayor Alt stated a resident of Heritage Woods questioned if he could purchase a right-ofway that leads to a parcel noted as a "neighborhood park" within the neighborhood. Mayor Alt queried if recreational equipment is required for the area. regulations in place at the time of development. She added that she would pull the original Public Works Agreement to find out additional details.

Mayor Alt announced that the Board is invited to attend the 138th Annual Banquet at Singerly Fire Company.

Mayor Alt announced the Little League Parade is scheduled for Friday, April 8th, asking the Board to meet at 5:45 p.m. at the ballfield. Mayor Alt added that Mr. Tim Eller asked Chief Rogers to walk with the Board during the parade.

Mayor Alt asked the Board to consider budgeting funds for audio/video upgrades to the Mayor & Commissioners meeting room.

#### **Commissioner Massimiano's Report**

Commissioner Massimiano thanked the volunteers who assisted with preparing the gear for the upcoming Fishing Rodeo. He stated he is meeting with the Cecil County Toys for Tots Campaign for assistance with prizes for participants, adding that he will accept all donations that can be used as prizes for participants.

#### **Commissioner Piner's Report**

Commissioner Piner stated he attended the Elkton Middle School production of Annie, Jr. on April 1st. He commended the students and production staff, adding his desire for a partnership between the schools and Cecil College for equipment and scholarships.

Commissioner Piner stated he attended the dedication of the Bernard Purdie mural at the Neighborhood Community Center (NCC) on April 2nd. Commissioner Piner thanked Mr. Purdie and his trio, keyboardist Meho Nobuzane and bassist Danny Boone. He thanked artist Bruce Gulick; Jessica Price and Margie Blystone of the Elkton Alliance; Ann Marie Hamilton and the Arts Council; Mary Magaw and Parks & Recreation; and the entire team that made the event a success.

Commissioner Piner expressed his desire for an annual Bernard Purdie Scholarship fundraiser event for Elkton High School music students.

Commissioner Piner, referring to gas line installation on White Hall Road, stated he spoke to the contractor regarding his concerns about restoration of the properties.

Commissioner Piner expressed concerns regarding the condition of the former Happy 40 store on Route 40. Mr. Downs stated the Zoning Director Chip Bromwell has been in contact with the property owner.

Commissioner Massimiano interjected his concerns regarding the condition of the former Minihane's Pub on Main Street.

# **Commissioner Givens' Report**

Commissioner Givens concurred with Commissioner Piner's comments regarding the Bernard Purdie mural dedication, offering kudos to all involved.

Commissioner Givens stated Mr. Purdie was part of the first integrated student body in Elkton.

Commissioner Givens offered his congratulations to Mr. Purdie for recognition of his accomplishments.

Commissioner Givens stated he visited Gilpin Manor Elementary on April 5th to assist children in kindergarten - 1st grade during lunch. He expressed his appreciated for a 4th grade student who recognized him from a previous Town-sponsored event, and suggested that the Board visit local schools.

Commissioner Givens requested an update regarding the property located at 213 East High Street. Mr. Downs stated the Deeds are awaiting the signature of County Executive Hornberger.

Commissioner Givens expressed concerns regarding the Holly Hall property.

# **Commissioner Broomell's Report**

Commissioner Broomell echoed the comments of Commissioners Givens and Piner regarding the Bernard Purdie mural dedication event.

Commissioner Broomell thanked Mr. Handley and the Department of Public Works for maintenance of the crosswalk at North and High Streets.

Mayor Alt added that the property at 107 North Street had been purchased and will be used as a music venue. He added that the property at 112 West Main Street was recently sold, as was the property at 105 North Street.

# **Public Comment**

Ms. Diane Hair echoed Commissioner Givens' comments regarding the Holly Hall property. Mayor Alt expressed frustration that the owner of the property is permitting it to fall into disrepair.

Hearing no additional business to come before the Board, Mayor Alt adjourned the meeting at 12:48 p.m.
