**AN ORDINANCE CONCERNING**

**The Code of the Town of Elkton  
Title 10  
Chapter 10.16**

**FOR THE PURPOSE of amending the Code of the Town of Elkton, Title 10, Chapter 10.16, extending the parking limitation to three (3) hours in certain areas.**

**WHEREAS,** Article XI-E., Constitution of the State of Maryland; Section 4-103(b)(3), Subtitle 1, Title 4, Division II, Local Government Article, Annotated Code of Maryland; and the Charter and Code of the Town of Elkton provide the authority under which the Board of Commissioners may adopt, repeal, and/or amend the ordinances of the Town of Elkton; and

**WHEREAS,** the Mayor and Commissioners have determined that certain parking areas in the downtown business district shall have the parking limitation extended from two (2) hours to three (3) hours on the street(s) and other municipal property as hereinafter indicated.

**NOW, THEREFORE,** the Board of Commissioners of the Town of Elkton hereby ordains that:

- Section 1. The Code of the Town of Elkton, Title 10, Chapter 10.16, Parking Schedules, shall hereby be repealed: and
- Section 2. The Code of the Town of Elkton, Title 10, Chapter 10.16, Parking Schedules, shall hereby be re-enacted to read as follows:

## PARKING SCHEDULES

**Sections:**

- 10.16.010** Parking time limited - Specified areas.
- 10.16.020** Special purpose parking areas. (Section not amended under this ordinance)

**10.16.010** Parking time limited - Specific areas.

No person shall park a motor vehicle or allow the same to remain parked upon any of the streets, parts of streets or parking lot(s) described below, between the hours specified, for longer than the time indicated below:






