AN ORDINANCE CONCERNING

**The Code of the Town of Elkton
Title 10
Chapter 10.16**

FOR THE PURPOSE of amending the Code of the Town of Elkton, Title 10, Chapter 10.16, Section 10.16.010, designating the parking lot behind 107 North Street to 117 -119 West Main Street Parking Lot.

WHEREAS, Article XI-E., Constitution of the State of Maryland; Section 4-103(b)(3), Subtitle 1, Title 4, Division II, Local Government Article, Annotated Code of Maryland; and the Charter and Code of the Town of Elkton provide the authority under which the Board of Commissioners may adopt, repeal, and/or amend the ordinances of the Town of Elkton; and

WHEREAS, the Mayor and Commissioners have determined that certain parking areas in the downtown business district shall have the parking limitation extended from two (2) hours to three (3) hours on the street(s) and other municipal property as hereinafter indicated; and

WHEREAS, the Mayor and Commissioners have further determined that the municipal parking lot previously designated as the “107 North Street Parking Lot” shall be designated as the “117 – 119 West Main Street Parking Lot.”

NOW, THEREFORE, the Board of Commissioners of the Town of Elkton hereby ordains that:

- Section 1. The Code of the Town of Elkton, Title 10, Chapter 10.16, Parking Schedules, shall hereby be repealed: and
- Section 2. The Code of the Town of Elkton, Title 10, Chapter 10.16, Parking Schedules, shall hereby be re-enacted to read as follows:

PARKING SCHEDULES

Sections:

10.16.010 Parking time limited - Specified areas.

10.16.020 Special purpose parking areas. (Section not amended under this ordinance)

10.16.010 Parking time limited - Specific areas.

No person shall park a motor vehicle or allow the same to remain parked upon any of the streets, parts of streets or parking lot(s) described below, between the hours specified, for longer than the time indicated below:
