AN ORDINANCE concerning

The Code of the Town of Elkton
Title 15
Chapter 15.04
Construction Regulations Generally

FOR THE PURPOSE of amending Section 15.04.070, Chapter 15.04, Title 15, Code of the Town of Elkton, specifically amending the penalty under this section to conform to Section C14.1(A), Article XIV, Charter of the Town of Elkton.

WHEREAS, Article XI-E., Constitution of the State of Maryland; Section 4-103(b)(3), Subtitle 1, Title 4, Division II, Local Government Article, Annotated Code of Maryland; and the Charter and Code of the Town of Elkton provide the authority which the Board of Commissioners may adopt, repeal, and/or amend the ordinances of the Town of Elkton; and

WHEREAS, the Board of Commissioners amended Section C14.1(A), Article XIV, Charter of the Town of Elkton by Resolution R1-2016, effective March 10, 2016, to provide for a penalty inclusive of a fine not to exceed One Thousand Dollars (\$1,000) and/or imprisonment not to exceed ninety (90) days, consequently the aforementioned penalty provision under Section 15.04.070, Chapter 15.04, is being amended to conform to the penalty provided in the Charter of the Town of Elkton.

NOW, THEREFORE, the Board of Commissioners of the Town of Elkton hereby ordains that:

Section 1. The Code of the Town of Elkton, Title 15, Chapter 15.04, Section 15.04.070 - Violation – Penalty, shall be repealed; and

Section 2. The Code of the Town of Elkton, Title 15, Chapter 15.04, Section 15.04.070 - Violation – Penalty, shall be re-enacted and read as set forth hereinafter.
