AN ORDINANCE CONCERNING

The Code of the Town of Elkton
Title 10
Vehicles and Traffic
Chapter 10.16
Parking Schedules
Section 10.16.010 Parking Time Limited - Specified Areas.

FOR THE PURPOSE of amending the Code of the Town of Elkton, Title 10, Chapter 10.16, § 10.16.010., Parking Time Limited - Specified Areas, adjusting the time period for two-hour parking on Main Street, North Street, Singerly Avenue, and West High Street in the specified areas.

WHEREAS, Article XI-E, Constitution of the State of Maryland; Article 23A, Annotated Code of Maryland; and the Charter and Code of the Town of Elkton provide the authority under which the Board of Commissioners may adopt, repeal, and/or amend the ordinances of the Town of Elkton; and

WHEREAS, the Mayor and Commissioners have previously enacted an ordinance to regulate parking on certain streets in the downtown business district; and

WHEREAS, the Mayor and Commissioners have determined that parking on Main Street, North Street, Singerly Avenue, and West High Street should be restricted to two-hour parking until 4:00 p.m..

NOW, THEREFORE, the Maryland and Commissioners of the Town of Elkton hereby ordains that:

- Section 1. The Code of the Town of Elkton, Title 10, Chapter 10.16, § 10.16.010., Parking time limited Specified areas, is hereby repealed; and
- Section 2. The Code of the Town of Elkton, Title 10, Chapter 10.16, § 10.16.010., Parking time limited Specified areas., is hereby re-enacted to read as follows:

The Code of the Town of Elkton Title 10 Chapter 10.16 PARKING SCHEDULES

§ 10.16.010 Parking Time Limited - Specified Areas

No person shall park a vehicle or allow the same to remain parked upon any other streets or parts of streets described below, between the hours specified, for longer than the time indicated below:
