AN ORDINANCE CONCERNING

**The Code of the Town of Elkton
Title 10
Vehicles and Traffic
Chapter 10.16
Parking Schedules
Section 10.16.010 Parking Time Limited - Specified Areas.**

FOR THE PURPOSE of amending the Code of the Town of Elkton, Title 10, Chapter 10.16, § 10.16.010., Parking Time Limited - Specified Areas, adjusting for a unified period of parking on Main Street, North Street, Singerly Avenue, and West High Street in the specified areas.

WHEREAS, Article XI-E, Constitution of the State of Maryland; Article 23A, Annotated Code of Maryland; and the Charter and Code of the Town of Elkton provide the authority under which the Board of Commissioners may adopt, repeal, and/or amend the ordinances of the Town of Elkton; and

WHEREAS, the Mayor and Commissioners have previously enacted an ordinance to regulate parking on certain streets in the downtown business district; and

WHEREAS, the Mayor and Commissioners have determined that parking on Main Street, North Street, Singerly Avenue, and West High Street should be adjusted to be uniform, as hereinafter provided.

NOW, THEREFORE, the Maryland and Commissioners of the Town of Elkton hereby ordains that:

- Section 1. The Code of the Town of Elkton, Title 10, Chapter 10.16, § 10.16.010., Parking time limited - Specified areas, is hereby repealed; and
- Section 2. The Code of the Town of Elkton, Title 10, Chapter 10.16, § 10.16.010., Parking time limited - Specified areas., is hereby re-enacted to read as follows:

§ 10.16.010 Parking Time Limited - Specified Areas

No person shall park a vehicle or allow the same to remain parked upon any other streets or parts of streets described below, between the hours specified, for longer than the time indicated below:
