Ordinance 5-2009 FY 2010 Annual Budget

INTRODUCTION: May 20, 2009

ADOPTED: May 20, 2009

WHEREAS, the Mayor and Commissioners are required to adopt an annual budget, as provided under the provisions of the Charter of the Town of Elkton, Article VIII, § C8-6, et seq.; and

WHEREAS, the Mayor, in accordance with the Town's Charter, hereby presents, as attached hereto and incorporated under this Ordinance, and as hereinafter amended, the budget for Fiscal Year 2010, including currently anticipated revenues and expenditures for the Governmental and Proprietary Funds; and

WHEREAS, the Board of Commissioners hereby accepts and adopts the Mayor's Fiscal Year 2010 budget as presented and/or as subsequently amended hereinafter.

NOW, THEREFORE, the Mayor and Commissioners of the Town of Elkton hereby ordain the following:

- Section 1. **Fiscal Year 2010 Budget.** That the FY 2010 budget is hereby adopted, as presented and/or as subsequently amended hereinafter, providing estimated and anticipated revenue and expenditures for the Governmental and Proprietary Funds for the period July 1, 2009 through June 30, 2010.
- Section 2. **Real Property Tax Rate.** That the FY 2010 Real Property Tax Rate shall be **\$0.464 / \$100.00** of the property assessment determined by the State Department of Assessments and Taxation, effective July 1, 2009.
- Section 3. **Personal Property Tax Rate.** That the FY 2010 Personal Property Tax Rate shall be **\$1.11 / \$100.00** of the personal property value determined by the State Department of Assessments and Taxation, effective July 1, 2009.
- Section 4. **Water and Sewer Rates.** That the water and sewer rates shall be charged and collected as set forth under the Code of the Town of Elkton, Title 13, Chapter 13.04, § 13.04.290, unless otherwise amended.

DATE OF EFFECT:

THIS ORDINANCE shall be effective on the **1st** day of **July, 2009**.
