Resolution R1 - 2008

A RESOLUTION of the Mayor and Commissioners of the Town of Elkton authorizing a salary adjustment for the Mayor and Commissioners.

WHEREAS, under the authority of the Charter of the Town of Elkton, Article IV., § C4-3., as amended by Resolution R5-2007, passed on October 17, 2007 and effective on December 6, 2007, the Mayor and Commissioners shall receive a salary and may adjust said salary by a Resolution of the Board passed during the regular course of business, but said adjustment shall not be applicable during the term of office of any member of the Board; and

WHEREAS, the Mayor and Commissioners commit increasingly more hours of their time to administrative duties, inter-governmental involvement, participation in government related organizations and community activities, as well as interaction with constituents; and

WHEREAS, the Mayor and Commissioners have deemed that their respective salaries should be adjusted commensurate with the time and quality of their commitment as public officials.

NOW, THEREFORE, the Mayor and Commissioners of the Town of Elkton hereby resolve the following:

- Section 1. That the annual salary of the Mayor shall be adjusted from Eight Thousand Dollars (\$8,000.00) to Nine Thousand Two Hundred Dollars (\$9,200.00).
- Section 2. That the annual salary of each Commissioner shall be adjusted from Seven Thousand Two Hundred Dollars (\$7,200.00) to Eight Thousand, Two Hundred Eighty Dollars (\$8,280.00).
- Section 3. That the annual salary adjustment shall be effective in accordance with the Charter of the Town of Elkton, Article IV., § C4-3, which provides that an adjustment to the salary of the Mayor and/or any member of the Board of Commissioners shall not apply during their respective term of office.
- Section 4. That the Mayor and Commissioners shall receive compensation at a rate of 1/26th of their respective annual salary on a biweekly basis consistent with the payroll administration for employees of the Town.
