Resolution R1 - 2005

A RESOLUTION of the Mayor and Commissioners of the Town of Elkton establishing fines for violations of the Code of the Town of Elkton, Title 10, Chapter 10.28, Bicycles, Skateboards and Play Vehicles.

WHEREAS, the Mayor and Commissioners enacted Ordinance 8-2004, effective on December 21, 2004, amending the Code of the Town of Elkton, Title 10, Chapter 10.28, Bicycles, Skateboards and Play Vehicles, declaring that a violation be a civil infraction, and further providing that all fines and penalties for violations shall be established by resolution; and

WHEREAS, the Mayor and Commissioners have determined that a person violating Chapter 10.28 for the first time shall receive a written warning from the Chief of Police or his designated representative and subsequently receive a fine(s) as set forth in this resolution.

NOW, THEREFORE, the Mayor and Commissioners of the Town of Elkton hereby resolve the following:

- Section 1. That a person first violating the Code of the Town of Elkton, Title 10, Chapter 10.28, Bicycle, Skateboards and Play Vehicles, shall receive a written warning from the Chief of Police or his designated representative.
- Section 2. That a person violating the Code of the Town of Elkton, Title 10, Chapter 10.28, Bicycle, Skateboards and Play Vehicles, for a second time within a one (1) year period shall be fined fifty dollars (\$50.00), said fine to be paid in accordance with the provisions of the Code of the Town of Elkton, Title 1, Chapter 1.08.
- Section 3. That a person violating the Code of the Town of Elkton, Title 10, Chapter 10.28, Bicycle, Skateboards and Play Vehicles, for a third time, or any subsequent time, within a one (1) year period shall be fined one hundred dollars (\$100.00), said fine to be paid in accordance with the provisions of the Code of the Town of Elkton, Title 1, Chapter 1.08.
- Section 4. That a person violating the Code of the Town of Elkton, Title 10, Chapter 10.28, Bicycle, Skateboards and Play Vehicles, and who receives a citation and is directed to pay a fine to the Town of Elkton, may, as provided under the Code of the Town of Elkton, Title 1, Chapter 1.08, § 1.08.060, elect to stand trial in the District Court for Cecil County.
