### Resolution R2-2009 Public Park - Hours of Operation

**A RESOLUTION** of the Mayor and Commissioners adopting operating hours for public parks within the town.

**WHEREAS**, the Mayor and Commissioners adopted Ordinance 2 - 2009, amending the Code of the Town of Elkton, Title 12, adding Chapter 12.20, Public Park Regulations; and

**WHEREAS**, Chapter 12.20, § 12.20.020, (1), Hours of Operation, provides that the Mayor and Commissioners shall set the hours of operation for parks by resolution.

**NOW, THEREFORE, BE IT RESOLVED**, that the hours of operation shall be effective as set forth hereinafter:

#### HOURS OF OPERATION

1. John P. Stanley Memorial - Meadow Park, J. Evans McKinney Commemorative Park, Marina Park, Howard's Pond, and other parks, as defined under Chapter 12.20, § 12.20.010 (1.), Code of the Town of Elkton, shall generally operate as follows:

March through October	6:00 a.m. - 9:00 p.m.

2. The Director, Parks & Recreation, may adjust hours of operation in John P. Stanley Memorial - Meadow Park for special activities and/or sporting events, e.g., Fourth of July, Elkton Junior Football, Cecil Soccer, or other authorized activities.
